Instructions

Please read these instructions carefully:

Eligibility

To register with the NIH Nonhuman Primate Reagent Resource you must be a Principal Investigator, Laboratory Director, or equivalent (public or academic institution), or a Director of Research or equivalent (private or for-profit institution).

Conditions of Use

Reagents are provided under the terms contained herein for use in studies employing nonhuman primates or nonhuman primate specimens, and in which a commercially-available equivalent reagent does not exist or is not readily available in the quantity needed.

Procedure

Registrants must submit the registration form with signatures. FAXed forms are acceptable. For each reagent requested, Registrants must complete and submit an online order form available at <http://www.NHPReagents.org> that describes the reagent, quantity requested, and its proposed use.

Shipping Costs

There may be charges to cover the production costs of some reagents. In addition, requesters are required to pay all shipping costs by establishing an account with an overnight shipping company, preferably Federal Express, and providing their account number to the NIH Nonhuman Primate Reagent Resource. Shipments are usually nonhazardous, shipped on cold packs using standard overnight delivery.

The United States Government, the University of Massachusetts and contributors of reagents ("Providers") MAKE NO REPRESENTATIONS AND EXTEND NO WARRANTIES OF ANY KIND, EITHER EXPRESSED OR IMPLIED, INCLUDING ANY EXPRESS OR IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, OR THAT THE USE OF THE REAGENT WILL NOT INFRINGE ANY PATENT, COPYRIGHT, TRADEMARK, OR OTHER PROPRIETARY RIGHTS. PROVIDER AND CONTRIBUTORS OF REAGENTS MAKE NO REPRESENTATION THAT THE REAGENTS SUPPLIED OR THE METHODS USED IN MAKING REAGENTS ARE FREE FROM LIABILITY FOR PATENT OR OTHER PROPRIETARY RIGHTS INFRINGEMENT. RECIPIENT AGREES TO HOLD PROVIDER HARMLESS FOR LIABILITY FOR INFRINGEMENT, CONTRIBUTORY INFRINGEMENT OR ACTIVE INDUCEMENT OF INFRINGEMENT OF PATENTS OR OTHER PROPRIETARY RIGHTS IN THE EVENT SUCH ACTION SHOULD ARISE FROM PROVIDER'S SUPPLYING REAGENTS HEREUNDER, OR RECIPIENT'S USE THEREOF. Unless prohibited by federal and/or state law, Recipient remains responsible for all liability for claims for damages against it by third parties which may arise from the Recipient's use, storage, or disposal of the reagent.

Material Transfer Agreements

Access to some reagents, as noted in the NHP Reagent Resource catalogue, may require that Recipient's institution execute a Material Transfer Agreement with a third party academic or private institution. Recipient agrees to review and consider, on a case-by-case basis, any Material Transfer Agreement necessary for gaining access to reagents available through the NIH Nonhuman Primate Reagent Resource. The Recipient also agrees to supply, upon request, documentation to the Provider to confirm that a Material Transfer Agreement has been executed.

Certification of Compliance with Safety Standards

Recipient is aware that all reagents distributed by the NIH Nonhuman Primate Reagent Resource may be potentially biohazardous even when they are not specifically designated by a biohazard symbol. Recipient understands that the requested reagent(s) may pose health risks to persons handling or in the vicinity of the reagents, the environment, and the community. Recipient is cognizant of and will employ the appropriate biosafety standards including special practices, equipment, and facilities. Recipient shall comply with all applicable Institution and Government health and safety regulations and the guidelines detailed in: Biosafety in Microbiological and Biomedical Laboratories (BMBL), 5th Edition, February 2007, U.S. Government Printing Office, Washington, DC, or the most recent revision of these guidelines. Recipient shall directly supervise all users of the reagent(s) and shall assume responsibility for assuring that those users are cognizant of and comply with safety standards and good laboratory practices.

Human Use

Recipient agrees to comply with Protection of Human Subjects, Title 45, Code of Federal Regulations, Part 46. None of the reagents provided by the NIH Nonhuman Primate Reagent Resource nor any Derivatives (defined as essentially unmodified progeny or materials created by the Recipient that incorporate a previously known unmodified functional subunit or product expressed by the original material) will be used in humans or for any clinical diagnosis without receiving prior written approval of the Director, Division of Allergy, Immunology and Transplantation, NIAID, NIH. The intent of these conditions is to protect both the rights and the welfare of human subjects, and to protect the Providers.

Animal Use

Recipient agrees that reagents provided by the NIH Nonhuman Primate Reagent Resource and any Derivatives will be used in animals only as described in: Public Health Service Policy on Humane Care and Use of Laboratory Animals, October, 2000, or the latest version thereof (copies may be obtained from the NIH Office of Laboratory Animal Welfare, TEL: 301-594-2506, email: olaw@od.nih.gov

Certification of Use

Recipient agrees that all reagents provided by the NIH Nonhuman Primate Reagent Resource, or Derivatives, will be used for research purposes only, in Recipient’s laboratory only, at Recipient’s Institution only, and only for the experiments proposed on the Reagent Request Form. Also, the reagents or Derivatives will not be allowed to come into the possession of any other persons except those engaged in research under Recipient’s direct supervision who accept these restrictions.

Assumption of Shipping Costs

Recipient agrees to assume the costs of shipping reagents by providing an overnight carrier shipping account number, or by making arrangements for prepaid shipments. No shipments will be made until Recipient’s proposed shipping arrangements are accepted by the NIH Nonhuman Primate Reagent Resource.

Commercial Use

No reagent provided by the NIH Nonhuman Primate Reagent Resource nor any Derivative will be directly incorporated into any commercial product or used directly to provide a commercial service without receiving prior written approval of the Director, Division of Allergy, Immunology and Transplantation, NIAID, NIH.

Acknowledgment of Source

Recipient agrees to acknowledge the NIH Nonhuman Primate Reagent Resource in all publications and presentations of studies utilizing reagents supplied by the NIH Nonhuman Primate Reagent Resource. The suggested form for acknowledgments is: “The following reagent was obtained through the NIH Nonhuman Primate Reagent Resource: (reagent).”

Reporting Agreement

Recipient agrees to provide the NIH Nonhuman Primate Reagent Resource with a description of the planned use of the requested reagents with each request. Recipient agrees to provide the NIH Nonhuman Primate Reagent Resource with copies of all publications in which Program reagents were utilized.
